4. The Agenda of the meeting is as under:-



6. The developers of the software i.e. NIC will also remain present in the meeting and will make a presentation on the revised OSMS. They will also address specific problems pertaining to States/UTs in implementation of OSMS in their respective States/UTs, if any, during the course of the meeting.
