# Subject: Allocation of trainees under USTTAD for the year 2017-18.

Sir,

I am directed to say that based on grading system placed before the Inter-Ministerial Screening Committee held on 15.03.2018 under Upgrading the Skills and Training in Traditional Arts/Crafts for Development (USTTAD), a scheme of the Ministry of Minority Affairs. The organizations (list enclosed) have been provisionally selected as a Project Implementing Agencies (PIAs) under the scheme. The Ministry has approved fresh tentative allocation of 16 number of minority trainees to be trained by the PIA under "USTTAD" during 2017-18. The final allocation of the trainees will be made subject to the satisfactory inspection report received from State Govt./MAEF Inspector/MoMA Officer. No fund will be released to the PIA if the inspection report is not found satisfactory.

2. The PIA is required to select the craft given at Annexure submit proposed number of trainees to be trained within the allocated trainees as per prescribed format by **15.04.2018**.

3. The PIA shall immediately start mobilization of allocated number of minority youths willing to receive trainings in traditional arts under the scheme who are eligible as per provisions of the scheme. It is advised that during mobilization, parents of the trainees may also be counseled. The mobilization should be completed within 15 days from the date of issue of this letter and submit details as per prescribed format (Annexures).

4. The organization shall focus on all minority communities namely i.e. Muslims, Christians, Sikhs, Buddhists, Parsis and Jains. They shall also maintain minimum 33% earmarking for minority girls as per guidelines.

5. The PIA will register itself on NGO Darpan Portal of NITI Aayog and provide unique id number to the Ministry alongwith the screenshot immediately. It is mandatory before release of funds.

6. The allocation is purely provisional and subject to scrutiny and verification of documents submitted by the PIA.

7. The sanction order/allocation order can be curtailed or stopped altogether if any discrepancies about the past work done and current assignment being done comes to the light without any compensation. This action can be taken alongwith other action for discrepancies mentioned in the Memorandum of Understanding (MoU).

8. It is requested to furnish the details in the prescribed format as requested at para 2 and 3 above.
