I am directed to convey the sanction of the President of India for an amount of Rs. 3,57,750/- (Rupees Three lakh Fifty Seven Thousand Seven Hundred And Fifty Only), towards the cost for organizing Leadership Development training for Minority Women for 125 (One Hundred And Twenty Five Only) Non Residential training for selected trainees at Nagaon District (Assam) and release of Rs.2,50,425/- (Rupees Two Lakh Fifty Thousand Four Hundred And Twenty Five Only) for Non -Residential as first installment(70%) during the year 2013-14, to Adarsha Samaj Kalyan Samiti, Beloguri, Natun Bazar, PO- Solmari-782002, Nagaon, Assam, as per details at Annexure - I. The above sanction is subject to fulfillment of following terms and conditions as given in para 2(i-xii) and the Guidelines prescribed under the Scheme:

2 (i) Grant-in-aid has been given to the above mentioned organizations on the basis of the recommendation of Government of Assam. It is incumbent on the part of Government of Assam to ensure that the organization recommended by them utilize the fund for the purpose it has been sanctioned.

(ii) The Organization will not obtain grant for the same purpose or activity from any other Ministry or Department of Government of India or State Government and or any other body.


(iii) The Organization will not divert grant-in-aid and entrust the execution of the project for which the Grant-in-Aid is sanctioned to another organization or institution. No funds out of this grant should be utilized for any new/other scheme for which prior approval of Government has not been obtained.
